## OKLAHOMA HORSESHOEING SCHOOL TUITION ASSISTANCE LOAN

- An OHS Tuition Assistance Loan generally covers ALL of tuition except for the initial enrollment fee.
- The interest rate is 12% annually
- A 9% origination fee is deducted from the loan. The balance of the funds go toward tuition.

- Payments are \$ 200.00 per month
- Payments begin the 1<sup>st</sup> day of the month, after class start date
- Interest does not start until the first payment is due
- There is no interest if you pay the loan in full before your first payment is due
- There is no penalty for prepayment
- There is a \$25 late fee on ALL accounts for payments received after the 15<sup>th</sup> of each month.

- The Oklahoma Horseshoeing School contract with the deposit for the course
- COMPLETED loan application. You must include a non-spouse family member as a co-borrower

## THE NEXT STEPS ARE:

- Credit application is processed.
- Upon approval of credit, a promissory note will be sent to the applicant and co-borrower.
- Completed promissory note is returned to Oklahoma Horseshoeing School with a copy of a current valid state ID and Social Security card for both Borrower and Co-Borrower.
